Topics, Speakers, Game-changers

The ideal 2017 session topic is directly related to the conference theme, **Building on the Basics:** Creating Your Tribe on the Move

The 2017 Families In Global Transition conference will revisit the basics: What is the definition of an expat? A Third Culture Kid? A foreign assignment? High mobility? A global family? The FIGT network of researchers, educators, counselors, relocation specialists, artists, humanitarians, entrepreneurs, students and parents will unpack the terms and frameworks that help make sense of global mobility's impact on identity, career and community development. Through discussion about updating definitions, we will advance our understanding of cross-cultural and globally mobile communities in an age of profound cultural, economic and political complexity. If a common basic need for our diverse communities is a sense of belonging, what are the practical steps to finding your "tribe" and helping others do the same?

#FIGT17NL requests proposals for conference sessions that address

- Rigorous (re) examinations of basic terms (e.g. expat, immigrant, migrant, global nomad, TCK, CCK, family, foreign assignment, high mobility, etc.)
- Privilege and hierarchies within Western/Anglo definitions of "global families"
- Advancing our understanding of the needs and responsibilities of mobile communities
- Practical resources for individuals, families and organizations to find their cross-cultural/globally mobile "tribe"
- Teaching, modeling and encouraging empathy, resilience and collaboration between "tribes" with differing needs/outlooks/approaches
- Consolidating research and support structures within the global mobility field
- Who is not "at the table" of our conversation at FIGT

Session Formats

CONCURRENT SESSION: Interactive, practice-based, solution-oriented workshops or presentations that appeal to attendees across sectors. Preference will be given to sessions with original, powerful information, practical resources and/or empowerment tools for families or supporting professionals. Conference attendees choose from 3-4 concurrent sessions occurring at the same time. Suggested format is 15 to 20 minute presentation and 40-45 minute active discussion on your topic.

KITCHEN TABLE CONVERSATION: Lively, interactive, brief

Presentations/conversations about a focused, practical topic, designed to expose conference attendees to a range of ideas and presenters. Presenters make a brief (8-10 minute) presentation of their topic, and then engage in a discussion (15-17 minutes). Attendees move from table to table; presenters propose the same conversation twice, to groups of 10-20 attendees each. These are ideal for new and experienced presenters alike.

IGNITE SESSION: Dynamic, structured talks allow presenters to share big ideas quickly to all conference attendees. Each presenter prepares 20 image-based PowerPoint slides, which advance automatically every 20 seconds, to accompany their "story." Preference will be given to presentations that are engaging, informative, and based on a powerful question/idea, as well as to speakers with robust presentation skills. Ignite Presenters will have the opportunity to engage in smaller group sessions directly after the presentations.

PANEL DISCUSSION: Expert panels can be an effective way to consolidate knowledge and lead a conversation across sectors and areas of experience/expertise. The ideal panel discussion will contain a big question of interest to constituents of all sectors, moderated by an experienced interviewer/facilitator. To propose a panel discussion, please fill out the RFP with your information as well as the information for another panel members; we will follow up with you regarding details on the complete panel.

KEYNOTE SPEECH: High-level lecture, presentation or performance. Can be followed by a Q&A at the presenter's discretion. Preference will be given to accomplished speakers or performers, with topics that address a universal theme relevant to all conference attendees.
